3 (a) The objects to be pursued by the company on its incorporation are:

To work towards elimination of practice of Child Labour and to take appropriate steps for their rehabilitation for the welfare and uplift of the needy children and also run adult education programmers.

? To develop hospital/ clinics, HIV/AIDS, covid-19 and other communicable diseases for poor people and needy person

? To make efforts for the overall development of the Society. To engage in all kinds of developmental work meant for the welfare of people living in urban slum areas;

? To organize self employment awareness events for women to uplift the status of women in the society and educate unemployed people specially youth.

? To organize and encourage social events for motivating youths to work in correct direction and empower women, youths towards enterprising activities which

will improve their standard of living both economically and socially and to contribute towards employment generation.

? To develop, promote basic medical facility, sanitation, general health care and other needful support which can be helpful for public to overcome sufferings and agony of any natural and manmade disaster and to facilitate them to rehabilitate.

? To provide accommodation, food, clothing, free education to orphan without parents, for helpless needy people.

? To provide the donation to the spiritual places.

? To promote the people to donate blankets, woolen, cotton, silk or other varieties of clothes or other articles of necessary and also provide the same to the needy man, women and children.

? To promote technical skill training and Industrial training centres for the self-employment schemes

? To promote cultural and artistic subjects / works like Drawings, paintings, music, shows, dramatic performances and dances reflecting / exhibiting the preaching of all religion?s heads of India, and Indian cultures / traditions.

? To develop Community and Natural Resources to give the right direction to people of the marginalized and economically weaker section of the trust for their sustainable overall development.

? To promote healthy environment by providing tree plantation on the park, road side and other various places in all over India level.

? To support and promote the growing of trees and drilling of bore wells, restoration of water tanks, taking up drinking water projects, water development programs and providing of space and rooms for

conducting religious functions or any other allied activities as the trustees deem fit from time to time.

? To develop nursing aid to needy people especially for the old age men and women, orphan ill etc.

? To promote, or help in maintaining and/or running hospitals, charitable dispensaries, mobile dispensaries, maternity homes, child welfare centers, convalescent homes, sanatorium, hostels and other similar institutions or centers for rendering or providing medical relief.

? To develop various innovative and creative women empowerment setup or bodies or centers for self-employment of individuals, women groups or units of women like self-help groups(SHGs)to make them self-sustainable through employment generation at rural and urban sector.

No objects of the Company shall be carried out without permission of competent authorities whomsoever and no objects of the Company shall be carried out on commercial basis however the company shall apply its profit, if any or other income in promoting its objects and to prohibit payment of dividend to its members.

the doing of all such other lawful things as considered necessary for the furtherance of the above objects:

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudence remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

7 The liability of the members is limited.

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.
